

This is an Agreement under which you become a Member of The Movement Collective. When you join as a member you are entering into a legally binding contract with us. These terms and conditions set out your rights to use the Facilities and Services at The Movement Collective and the responsibilities you have as a Member. These responsibilities, including payment of Membership Fees, do not depend on how often you use the Facilities and Services. What is set out in this Agreement overrides any statements made by you or us before you sign it so you should read through it fully to make sure it reflects your expectations. If you are unsure whether any particular statements that you have relied on are part of this Agreement, or if you have any queries regarding this Agreement, please ask us before you sign.

Direct Debit Information: If an automatic direct debit arrangement is in place, your Membership Fees will continue to be debited from your account until you or we cancel the arrangement. If you end this Agreement or stop the automatic debit arrangement in a way not described in this Agreement, you may be liable for unpaid Fees or damages for breach of contract.

Outstanding money: It is your responsibility to ensure there are enough funds for your membership fees to clear each week. If your membership fees bounce you will need to use the TMC App to re-process the transaction. The Movement collective reserves the right to terminate any contract with more than 4 weeks of payments owing on the account. Your bank or credit provider may charge you a fee for overdrawing your account. Our third-party Biller Quickpay may also charge you an Administration Fee if there are insufficient funds available.

Medical Information: You agree to give us all relevant health and fitness information before or during any exercise. Each time you use the Facilities and Services, you must ensure you are in good physical condition and know of no medical or other reason why you should not exercise. If unsure, you should seek medical guidance.

Suspensions and Terminations: This is an open contract which means you are able to terminate or suspend your membership at any time with 2 weeks notice. You can place your membership on hold for a maximum of 4 weeks during a 12 month period. Once the suspension period ends your membership fees will automatically begin again without further notice.

Debt collectors: Your membership will not be able to be suspended or terminated with outstanding money on the account. Refusal to pay outstanding money on your account will result in debt collection agencies and other legal avenues which can result in bad credit.

Membership price increases: Open contracts are subject to price increases

Making Changes to your membership: All enquiries and notice for suspensions and terminations must be submitted via email only to info@themovementcollective.net. Text messages, facebook messages, face to face conversations, telephone conversations are all unacceptable methods of contact.

Open Gym: As part of your membership you have access to using the gym outside of class times. Please note that you are not able to bring anyone with you for open gym that is not a paying adult member. Children are not permitted to use open gym (babies in prams/carriers are an exception).

Booking for classes: All classes and open gym sessions must be booked through the TMC App

Sauna: The sauna membership is a separate membership and is not included with this membership. Saunas can only be used by booking an appointment.

Children in class: This membership includes 930am classes. This class has a helper available to help watch the children, however if your children are of walking age it will be your responsibility to ensure they stay in the designated fenced area. Children are not permitted to be in the gym space where class is happening as it is a hazard to everyone in class.

Children playing on equipment During 930 classes there will be equipment in the fenced area for children to play on, mats, boxes etc. however children are not permitted on any other equipment outside of this area and time unless they are taking part in a TMC kids

class with a teacher supervising.

Creche service: The creche service is subject to change and may be cancelled at anytime
